Public service concession signed for aquatic centre to be built in Amiens

Alain Gest, Chairman of Amiens Métropole urban authority, and Olivier de Guinaumont, CEO of Cap Samaro, have signed a public service concession contract for the design, construction, financing, operation and maintenance of the future Amiens Aquatic Centre in Rue Alexandre Dumas.



The aquatic centre

Aimed at providing the key location for aquatic leisure activities for Amiens and surrounding areas, this project includes the creation of a 50-metre all-season, outdoor swimming pool which will be used, in particular, as the training centre for Amiens Natation club swimmers. A 25-metre indoor pool and a play pool will cater for families and school groups who will also be able to enjoy beaches which are to be installed outside. On the upper floor, a spacious fitness and well-being area with focus on health, exercise and relaxation will feature an indoor water slide leading down to the pool area¹.

This facility will comply with a sustainable development approach, with its energy consumption optimised by recovering heat from waste water and recovering water from footbaths².

Cap Samaro consortium

The Cap Samaro consortium, including Eiffage, Mirova, ENGIE Cofely and Swimdoo, is combining the expertise of each of its partners in order to build and operate the future aquatic centre ordered by Amiens Métropole.

The Eiffage Group's Concessions division developed the project for the future Amiens Aquatic Centre in partnership with other members of the consortium and will be mobilised to monitor the facility's design and conception phases until it is ready to be handed over in May 2019.

As consortium leader, Eiffage Construction Picardie will be responsible for the building work.

Mirova, subsidiary of Natixis Asset Management, is backing the project via its BTP Impact Local investment fund.

Swimdoo, a joint subsidiary founded by ENGIE Cofely and the Récréa group, will take charge of the facility's commercial operation. Swimdoo is focused on the analysis and integration of two of today's major societal requirements: the increasing need to foster social bonds, to bring people together and promote solidarity, and the importance of health and well-being.

ENGIE Cofely will be responsible for supplying fluids, maintenance, and major overhauls and renewal of equipment. ENGIE Axima will take charge of technical work packages.

Handover in May 2019

Having entrusted the construction of its future aquatic centre to Cap Samaro, Amiens Métropole will be able to provide its users with high-quality service, thanks to the expertise and the financial, human and logistical resources mobilised, with risks being transferred to the concessionaire.

The concession contract is for a period of 23 years, including 20 years of operation.

Work on the aquatic centre is to start in September 2017 and the centre is due to open in May 2019.
